Acknowledgment Scenario #19: Policy Cancellation Errors

An Insured Record (PC1) is submitted for a cancellation by insurer transaction with a missing Employer Notification Date (DN0331). ~~There are no errors found on the Insured Record (PC1). The Employer Record (PC2) has an invalid Employer FEIN, which is mandatory in the specific jurisdiction. The Employer FEIN (DN0016) on the Employer Record (PC2) contains all the same digits, i.e. 444444444.~~

~~Both the Insured Record (PC1) and the Employer Record (PC2) are is~~ rejected because the Employer Notification Date (DN0331) ~~from the Employer Record (PC2)~~ is required to process the Cancellation.

The Insured Record (PC1) is rejected using Employer Notification Date (DN0331) Entire Batch/Transaction (DN0000) in the Element Number (DN0115) and Must be a valid date (EN029) and Invalid Data Relationship (EN064) in the Element Error Number (DN0116). ~~to reflect that the record is rejected due to an error with another record in the transaction.~~

~~The invalid Employer Record (PC2) Acknowledgment detail is populated with the invalid Employer FEIN (DN0016) in Element Number (DN0115) and All Digits Cannot Be the Same (EN040) in Element Error Number (DN0116).~~

~~Note: When a policy is established with a single insured record only, the jurisdiction should not attempt to match and edit an employer record to that policy that contains only an insured record.~~
