The Claims Committee found that a DP rule was not included for Permanent Impairment Body Part Location Code as part of the original IRR. This clerical IRR will include the same DP rule as Body Part Injured with the exception of expanding the codes to the 3 digit codes allowed for Permanent Impairment Body Part.
